## **Options for obtaining an IRS Verification of Non-Filing Letter**

All non-tax filers are required to provide an IRS Verification of Non-Filing Letter dated on or after October 1, 2021, that indicates that a 2021 IRS income tax return was not filed with the IRS.

- Online Request Go to <u>www.irs.gov/transcript</u>, Click Get Tax Record
- "Get Transcript Online." Make sure to request a 2021 Verification of Non-Filing Letter. Note: If at any point you cannot validate your identity using the "Get Transcript Online" option, you may use the "Get Transcript by Mail" option. Takes about 5 10 business days.
- Paper Request Form <u>IRS Form 4506-T</u> follow form instructions.
